<b>Other information:</b>	<p>Appropriate safety practices must be followed during transfer of refrigerant from a refrigerating system to a refrigerant container for transport or storage. Land Transport Rule: Dangerous Goods 2005 (and its amendments). Gas cylinders must be marked with: the proper shipping name, the United Nations number, preceded by the letters UN, a class label (red diamond). Gas cylinders must not be stored on the transport vehicle near a source of heat. The cylinder must be stored upright so the pressure release device communicates with the vapour space. The main cylinder valve must be shut and any regulator removed prior to loading. Ventilation is required to prevent the build-up of flammable gas in the event of a leak.
